A RESOLUTION TO LEVY AND ASSESS A TAX FOR COLONA PUBLIC LIBRARY DISTRICT OF THE COUNTY OF HENRY, STATE OF ILLINOIS FOR THE FISCAL YEAR BEGINNING JULY 1, 2023 AND ENDING JUNE 30, 2024

BE IT RESOLVED, that the Colona Public Library District of the County of Henry and State of Illinois shall levy a tax of 0.02% of the value of all taxable property within said District, for building and maintenance purposes, subject to the right of the electors in said District to petition and require an election concerning the imposition of such tax, pursuant to 75 ILCS 16/35-5.

BE IT FURTHER ORDAINED, that within fifteen (15) days from the date of adoption of the ordinance, it shall be published in the Dispatch, a newspaper of general circulation in the Colona Public Library District and it is effective immediately upon adoption.

- Is available at the desk of the COLONA DISTRICT PUBLIC LIBRARY, 911 1ST Street, Colona, Illinois, during normal business hours and may be filed there during normal business hours.
- 2. Must be signed by 10% of the total number of voters residing within the district.
- 3. Must be filed on or before 30 days after the date this Notice was published, and
- 4. If such question were submitted to a vote, the proposed referendum would be on March 19, 2024.

AN ORDINANCE FOR THE LEVY OF TAXES FOR THE LIABILITIES OF THE COLONA DISTRICT PUBLIC LIBRARY, HENRY COUNTY, ILLINOIS; FOR THE FISCAL YEAR BEGINNING JULY 1, 2023 AND ENDING JUNE 30, 2024.

BE IT ORDAINED BY THE BOARD OF LIBRARY TRUSTEES OF THE COLONA DISTRICT PUBLIC LIBRARY:

Section 1: That for the purpose of defraying all of the necessary expenses and liabilities of the Colona District Public Library for the fiscal year beginning July 1,2023 and ending June 30, 2024, a tax for the following sums or so much thereof as may be by law authorized, be and the same is hereby levied against all taxable property in said District:
